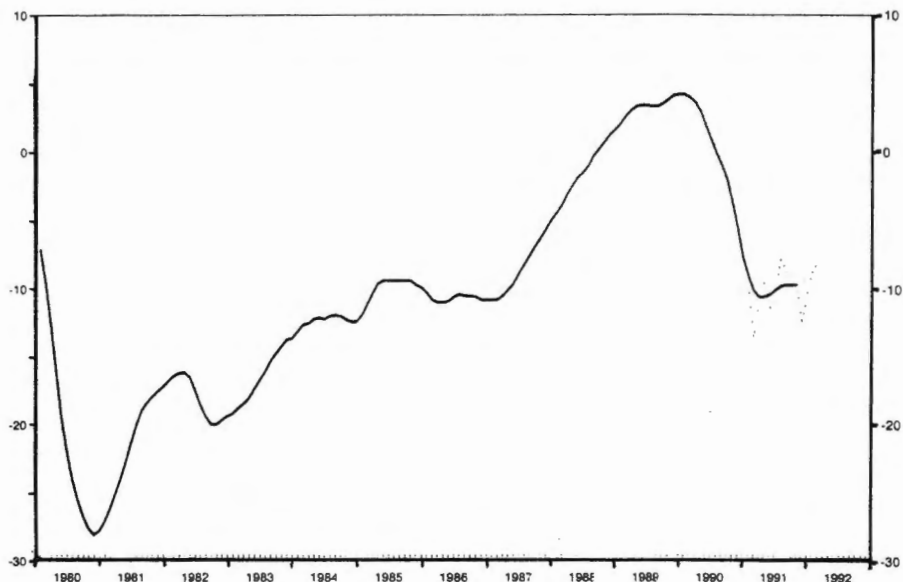

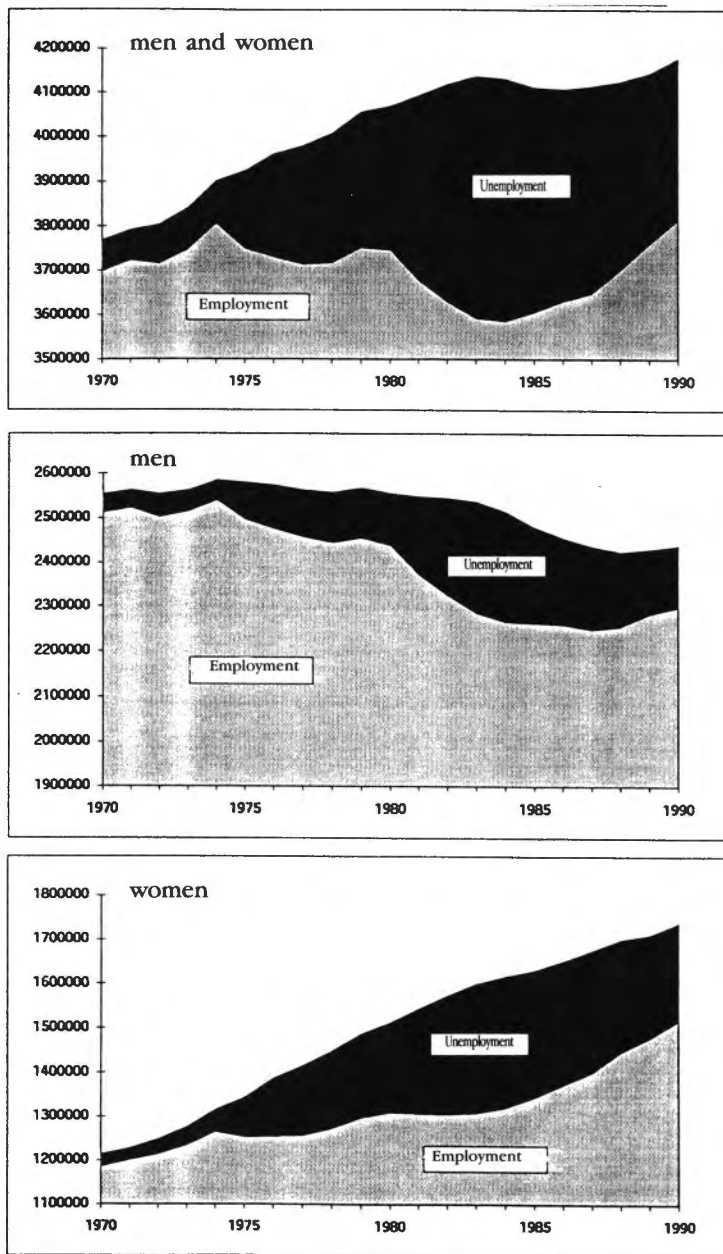

Opinion poll Marketing Unit

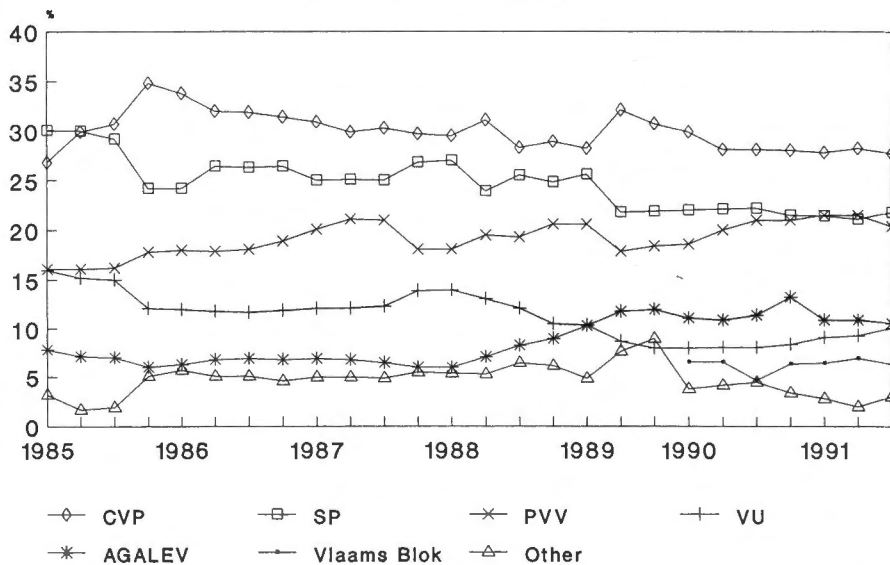
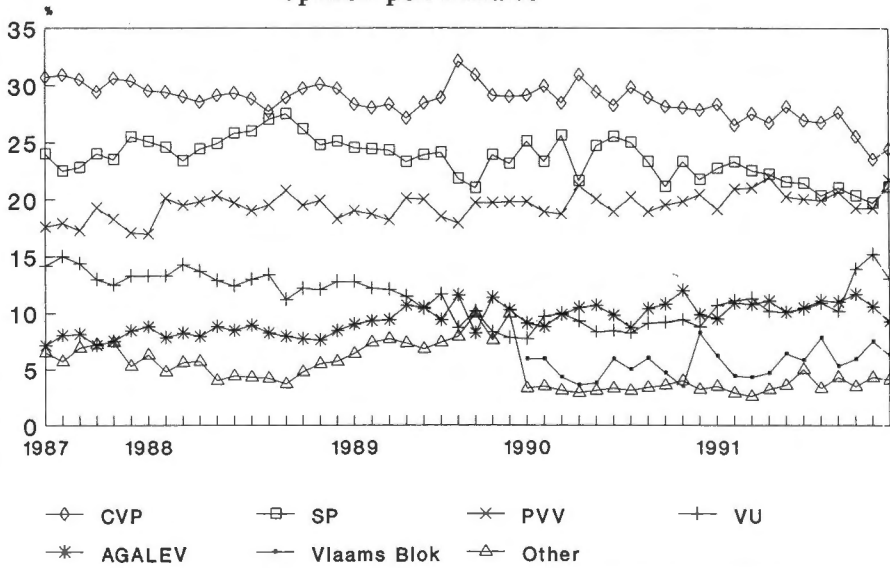

Opinion poll Dimarso

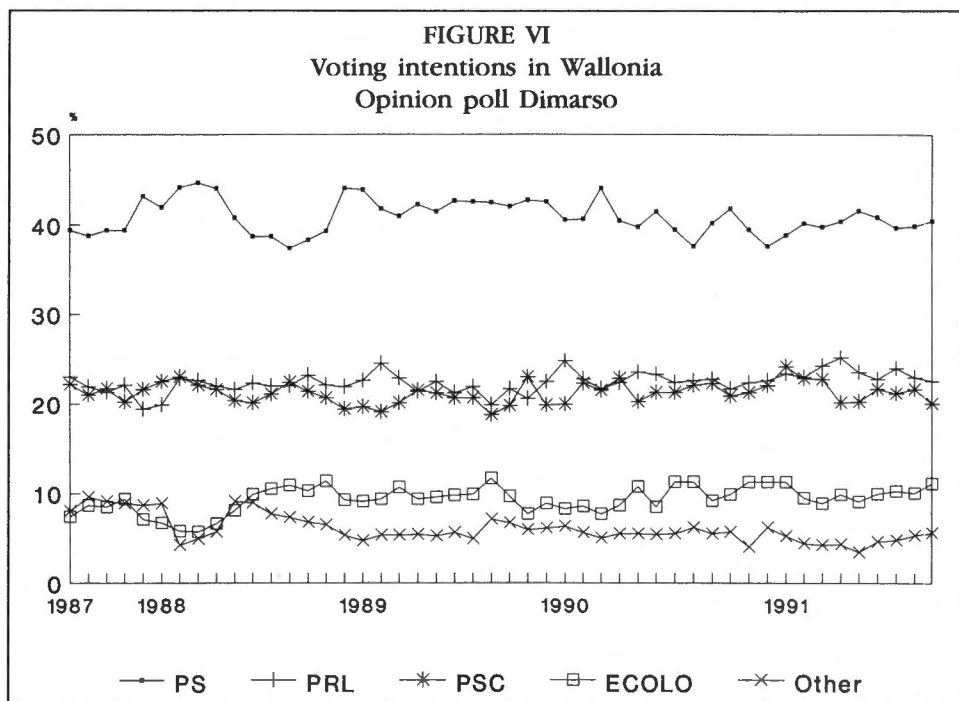
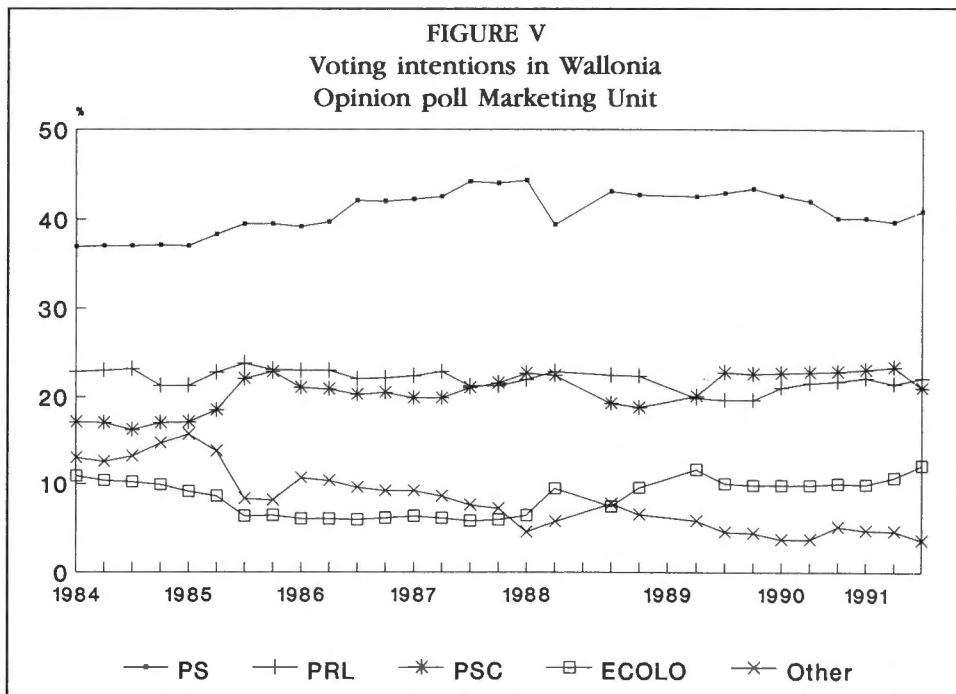

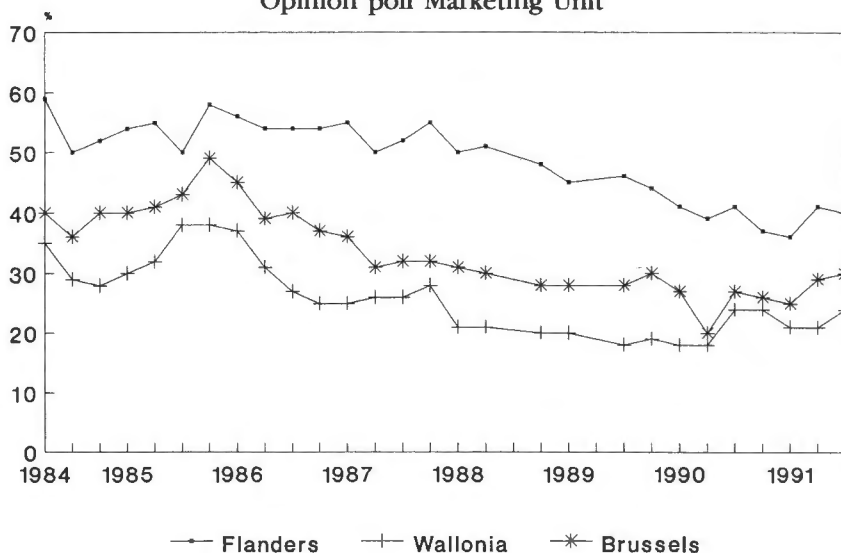

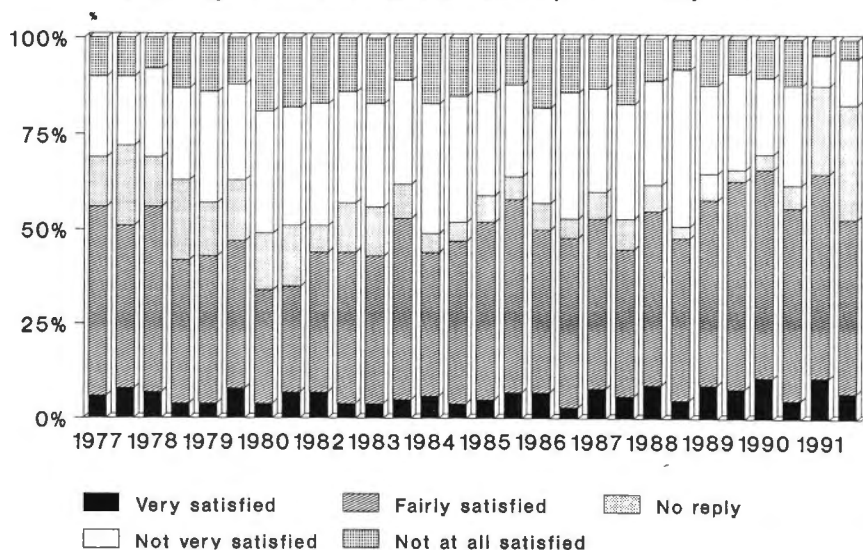

B. Cabinet stability

Valid and important indications pointing to cabinet stability or instability are the number of governments and the permanence or circulation of Ministers within the Cabinet (their persistence or alternation in particular).

Continious and cumulative experience measure more precisely the degree of permanent participation of Ministers to the national government.

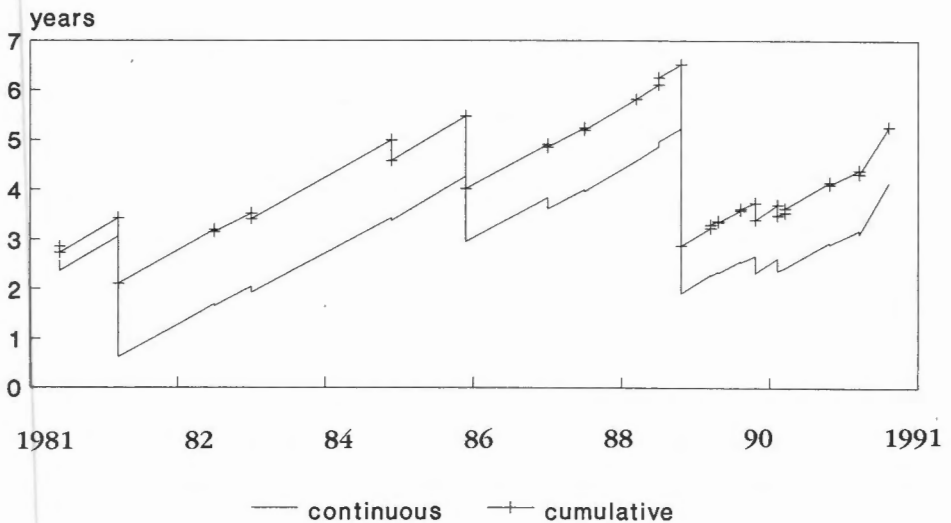
Two different indicators, *continious experience* and *cumulative experience* are being used.

-Continious experience indicates the average amount (in years) of uninterrupted service of all Ministers and State secretaries.

-Cumulative experience indicates the average amount of the total service of all Ministers and State secretaries.
